We are pleased to inform you that you have been awarded a fellowship for the Teaching Excellence and Achievement Program (TEA), a program of the Bureau of Educational and Cultural Affairs (ECA) of the U.S. Department of State, implemented by IREX. The TEA program provides Fellows the opportunity to participate in customized professional development courses at a U.S. university in the areas of teaching methods and instructional technology, as well as participate in a practical field experience at a U.S. secondary school.

Your program will begin on or about January 31, 2012 through on or about March 23, 2012. The following will be provided under the terms of the fellowship: J-1 visa support; a pre-departure orientation held in your home country; round-trip airfare from your home city to and within the U.S.; a Welcome Program in Washington, D.C.; academic program fees; housing (generally shared with other program fellows); accident and sickness insurance; a daily allowance for meals and incidentals during the university academic program; a professional development allowance; an End of Program Workshop in Washington, D.C.; an excess baggage/shipping allowance; and the opportunity to apply in the future for TEA Alumni Grants.

Please submit the <u>four</u> important documents listed below to your contact at the United States Embassy or Fulbright Commission in your home country by **September 23, 2011** to confirm your acceptance of the Fellowship:

- 1. Terms and Conditions of Participation: Review, complete and return Fellow Acceptance Form;
- 2. **Medical History and Examination**: Complete and Sign Part I (Medical History) before a qualified physician completes and signs Part II (Physical Examination Form);
- Technology Skills Survey: Please honestly evaluate your technology skills to the best of your ability:
- 4. **A color copy of your international passport**, valid beyond September 2012, including the photo and all relevant information pages (if not already submitted with your application).
